It is meant to be used together with a lifestyle therapy regimen involving a reduced calorie diet and increased physical activity. Phentermine comes in tablets and is taken as a single daily dose. Take the medication exactly as it is prescribed for you. The directions will be on the prescription label. Phentermine is only prescribed for short term use, up to 12 weeks.

Side Effects

This is not a complete list. These are the most common side effects of phentermine. Please, tell your doctor or nurse about any unusual or bothersome side effects. A very serious allergic reaction to this drug is rare. However, seek immediate medical attention immediately if you notice any of the following symptoms of a serious allergic reaction, such as: rash, itching and swelling (especially of the face/tongue/throat), severe dizziness, and trouble breathing.
